# 2016 Fashion Revue guidelines for County and State



## Traditional

This category features garments the participant has constructed for him/herself, showcasing sewing skills and the ability to coordinate an outfit. The outfit must contain at least one constructed garment. Participants are encouraged to construct additional garments to complete the outfit.

## Consumer Science Purchased \$40 limit

The \$40.00 expense limit is for the entire outfit, including shoes but not sales tax. Receipts from the current 4-H year are required for all items that are visible. Gifts, prior purchases, and items without receipts are not eligible for this category. Receipts from yard sales, etc. may be hand written.

## For All Entries

All outfits must meet SFR modesty guidelines. Formal wear may be strapless or have spaghetti straps. Backless dresses, excessive visible cleavage, visible undergarments, lingerie or swim suits are not permitted. All shorts, skirts, dresses, etc. must be at least fingertip length. All outfits must be suitable for comfortably walking, sitting.

## Upcycled

Take one or more existing garments and turn them into a new, different, and wearable garment. Add an accessory handmade made by the participant. Additional upcycled and/or sewn garments are encouraged to complete the outfit. A "before" photograph showing the original garment is required. This is not an alteration such as a large dress altered to fit a smaller person. It is a complete change such as pants and a shirt made into a dress. Other fabrics and material may be added during the construction process.

## Muslin Challenge

Create a wearable garment using at least 2 yards but not more than 3 yards of bleached or unbleached cotton muslin, 36-45" wide. Use of other fabric besides the muslin that shows is allowed, not to exceed 1 yard. Use of other fabric that doesn't show, like lining or interfacing, is also allowed. Members are encouraged to decorate and embellish the muslin garment using dye, paint, embroidery, "bling,"

## Western Challenge

In this category construct a western-style shirt/blouse with short or long sleeves. Use of any pattern and any fabric is allowed. Include handmade or purchased garments and items to complete the outfit. The entry must be sewn by the 4-H member as part of the 4-H Clothing & Textiles project. (New 2016)

## Service Projects:

**Multi-use Bags** made of recycled sturdy fabric or feed bags. Research needs within your community for the donations. Ideas are food banks, the library, and non-profit thrift stores

## Port Pillows

These are for cancer patients who have a portacath for chemo infusions. These little pillows make driving more comfortable. See the SFR website for the supplies and instructions .

## For both:

See the State Fashion Revue website for patterns, supplies needed, and instructions. Bring your service items with you to State Fashion Revue or mail them directly to us. You are welcome to keep them in your counties and deliver them personally but be sure to send us a count so we can keep track of the number made by our generous 4-H community.
