#### 2008 – 2009 ON- LINE ENROLLMENTS

The CA State 4-H Office and the 4-H Enrollment Task force has rolled out a new web-based 4-H enrollment and data management system, named 4hOnline.

Enrollment packets were given to Community Club Leaders at the On Line Enrollment training July 30th. New enrollees will be required to fill out hard copy paperwork. Re-enrollees will be required to enroll on line. What does this mean if you are re-enrolling on line? You will need to provide your Community Club Leader with an up to date email addres in order to receive your password.

All Club leaders will be required to have new enrollments to the 4-H office with payment by November 3rd, 2008.

#### SERVICE ANIMAL PROJECT

The Service Animal Project (Guide Dog Puppy Raising) is available to all 4-H members of Monterey County. Meetings are held on the first Monday of the month. You will have a chance to learn about blindness, guide dogs, puppy raising and handling. You can earn communication, community service, project exhibit credits, and more. You can even hold an office.

If you have dedication, you can raise a puppy full term, in which you will raise, groom, train, and socialize a puppy for 12-18 months. If you prefer, or cannot keep a puppy that long, you can raise a starter puppy. You will receive a puppy at 8 weeks old and keep it for 2 months, the puppy would then be transferred to another raiser home. You can also raise a transfer puppy, you will receive a puppy age 4 months or older and keep it until its recall for formal training. But, sometimes the transfer puppy will be quite older than 4 months of age, and you will only keep it for a few months.

If you cannot raise a puppy of your own, you can do short or long term puppy sitting for other members of the club. If you cannot have a puppy in your house at all, you can still be in the project. We're always looking for help with planning meetings, outings, or fundraisers.

If the service animal club sounds like too much commitment, or you're unsure about the project, you can join the Introduction to Guide Dogs project. This project only includes a field trip to the Guide Dog for the Blind Inc. campus for a graduation. A class of fully trained guide dogs are presented to their new blind parents. The Introduction project will also sit in at one of the Monterey County Guide Dog meetings to see what they are like.

#### STATE RECORD BOOK JUDGING

#### **Time Line**

September 30, 2008 - Applications to Judge Due October 31, 2008 - Books Due December 5 - 7, 2008 - State Judging

**Age Eligibility for the 2008 Competition:** Senior 4-H members (at least 14 years of age and no older than 19 years old by December 31 of the program year for which the book is being entered) are eligible to enter state competition. This means that 4-H member born anytime in 1989, 1990, 1991, 1992, or 1993. (between January 1, 1989 and December 31, 1993.) are eligible.

**State 4-H Cover Page** - The State 4-H Judging Cover Page must be included with 4-H Record Books entered for State Judging. The Cover Page may not be altered. 4-H Record Books missing the Cover Page will be reason for disqualification.

**County Check Sheet** - A county check sheet must be included with 4-H Record Books entered for State Judging. A committee, authorized by the County 4-H Office, must complete the checklist and ensure the completeness of the 4-H Record Book. 4-H Record Books missing the Check Sheet will be reason for disqualification.

**Previous Years Materials** - Materials from all previous years in 4-H must be removed and replaced with a summary of your previous involvement in 4-H (the 4-H member may include all involvement as a 4-H member, including primary). These pages must be placed at the back of the 4-H Record Book and must conform to the standard formatting and page guidelines. More information is available in the 4-H Record Book Manual on page 35 - 36.


#### **ACCOMODATIONS:**



#### BACKGROUND

• You might not think that landscaping and lawn care have anything to do with energy. But, as Sierra Club founder John Muir said, "everything is hitched to everything else."

#### **ENERGY FACTS**

- During the summer, the majority of household water is used for keeping yards green.
- Even in places where water doesn't have to be moved long distances from source to tap, a significant amount of energy is required to treat and process it before it enters the water mains.

#### SIMPLE WAYS TO SAVE ENERGY

- Treat you lawn right:
- Use a push mower instead of a power mower to save energy and reduce carbon dioxide emissions by up to 80 pounds per year.
- Set you mower blades to the cut grass about 2-3 inches tall. Mowing it shorter dries out the soil faster and increases water use.
- Let grass clippings turn into mulch. During dry periods, cut the grass high and leave clippings on the lawn to keep it from drying out thus reducing the amount of water your lawn needs.
- Most lawns need about 1 inch of water a week once they're established. Apply it slowly so the water doesn't run off.
- Here's how to tell how long it take s to apply an inch of water: Set two or three cans out on the lawn and turn on the sprinkler. Check every few minutes to see how land it takes to land and inch in each can. Average the times for the cans, and that's the length of time to water.

#### WATERING SMART

- Water in the early morning or very late afternoon to cut down on how much water evaporates before it reaches the roots.
- Try drip irrigation for shrubs and garden plants. It's a way of putting the water in small, steady amounts right to the soil around the plant you're watering.
- When you re-landscape, group together the plants that need similar amounts of water. That way, you can avoid overwatering one just to irrigate another.

#### **GOING NATIVE**

- Consider plants for your yard that are already adjusted to local conditions and don't require extra water or attention. These are usually plants that are native to your area.
- Think about shrubs, succulents, and trees as a substitute for some of your lawn. Nothing requires more water than a lawn.
- When you're ready to reseed or resod your lawn, look for grasses that require less water to thrive.
- Check your local government or PS&E Web site for information about water conserving plants. These
  plants are also called 'drought tolerant' and the practice of landscaping to conserve water is called
  "xeriscaping."

The show dates are August 21 & 22. This year, the California State 4-H Horse Classic will also be a qualifying show for the State Fair. If you exhibit in the State Fair 4-H Horse Show, you are eligible to compete. The champions and reserve champions for each division are required to compete. Others not exhibiting may pay a \$10 fee the day of the event. The competition includes a written Champion Challenge Exam on Wednesday, August 22nd at 8 AM. Those receiving a qualifying score will participate in further competition and interviews. The top prizes are \$250 to \$2,000 savings bonds.
- 2007 State 4-H Record Book Judging will take place November 30 December 2, 2007. Books must be postmarked by October 31, 2007 and be limited to the twelve-month period for the 2006-2007 program year. Safety Note #21 HIKING SAFETY

Clover Safe notes are intended primarily for 4-H volunteers and members nine years



4-H members participate on hikes that take place in terrain ranging from relatively flat land to steep, rugged topography and from wetland to desert conditions. Precautions to prevent injuries vary somewhat depending on the type of terrain and habitat encompassed by the path of the hike.Common injuries that are related to hiking include strains, sprains, cuts, bruises, insect bites, and sunburn. By taking several simple precautions and becoming familiar with the area and path to be hiked, 4-H members can control and/or reduce exposure to conditions that may cause injuries.

The following precautions should be followed to reduce the potential for incurring hiking-related injuries:

- Good safety practices are to (1) tell someone (that is not participating) the hiking route and when the hikers should return or complete the hike, (2) hike with a group or partner
- in remote areas, (3) bring adequate water for the weather conditions, and (4) carry a first aid kit and cell phone or other communication device while hiking.
- When possible, know the route(s) you will be taking during your hike.

Carry a reference hike-route or -location map, if necessary.

- In case of an emergency, know how to direct emergency responders to your location or transport an injured person to the closest medical facility.
- Do not wander from your hiking group or partner.
- If you notice that a member of your hiking group is missing, immediately notify your project leader, parent, or guardian.
- Always treat hilly and mountainous topography with caution. Carefully pick the spots where you intend to step. Be careful of dislodging rocks onto other hikers below or following you.
- Walk carefully in uneven terrain, especially when the ground surface may be obscured by vegetation or during twilight or at night.
- Dress appropriately for the weather conditions and hiking path terrain: as necessary wear a hat, long pants, boots or sturdy shoes, jacket, and skin and eye protection (i.e., sunscreen and sunglasses).
- Use insect repellants containing compounds such as DEET (repels insects) on exposed skin and permethrin (kills many insects on contact) on clothing only.
- Rock climbing without proper experience or equipment is dangerous and ill advised.
- Always be aware of potential temperature extremes associated with the hiking path and area. Dress appropriately for extreme temperatures that may cause heat or cold stress.
- Be particularly alert for falling rocks, rock slides, or rock falls when hiking in proximity to cliff faces or steep rock outcrops. Wear a safety hat when hiking in areas where falling rocks are common.
- When hiking in wet areas or in proximity to water, beware of stepping onto slippery rocks, slopes, or ground.
- When hiking in wetland areas, be cautious of stepping onto unsupported vegetation, soft mud, or quicksand. Use a pole or branch to probe the path surface ahead of you when crossing wetland areas.
- Be conscious of tidal cycles when hiking in coastal and estuarine wetland areas. Consult tide tables or similar reference materials and plan your hike accordingly.
- Whenever a lightning threat becomes apparent, move to a low spot and seek shelter immediately.
- If you encounter a snake, remain calm and back away slowly. Always give snakes plenty of room to escape from you. Never approach, tease, corner, or poke at any snake.
- Closely look for snakes or insects before placing your hands on objects such as rock outcrops or trees or picking up objects from the ground (i.e. rocks, plants, leaves, etc.)
- Thoroughly inspect the area where you intend to sit, particularly around stumps, logs, boulders, or rock outcrops.
- If you experience an insect bite or sting, wash the wound with soap and water, apply an antiseptic, and cover the wound with a band aid or clean dressing. Carefully remove stingers from skin by using tweezers and then clean and dress sting wounds. Never scratch an insect bite or sting.
- Promptly seek professional medical attention if you suspect you are experiencing severe venom allergic reaction symptoms.
- If a snakebite occurs: calm the victim, wash the area of the bite with soap and water, apply a cold dressing over the bite area, and immediately transport the victim to the closest medical facility for professional treatment. Also, remove jewelry, watches, and tight clothing in preparation for tissue swelling.
